***Net assets for these purposes do not include:**

- The property which is my primary residence or any capital raised through a loan secured on that property;
- Any rights of mine under a qualifying contract of insurance (e.g. an endowment or life insurance policy);
- Any benefits (in the form of pensions or otherwise) which are payable on the termination of my employment, or on my death or retirement, and to which I am (or my dependants are), or may be, entitled.

Example: A person, aged 55, has savings totalling £48,000 in ISAs, bank accounts and savings accounts; a house which is mortgaged; a pension which is payable at 65, and a life insurance policy payable on death. The person has credit card bills of £1,000. The person has no investments in non-readily realisable securities prior to those of Oikocredit.

The person's net assets are therefore deemed to be £47,000, and they may invest up to £4,700 in Oikocredit and/or a similar investment.

4b. OR YOU ARE A SOPHISTICATED INVESTOR
